# PRESIDENT'S LETTER

Thank you for the great turnout at the "emergency" RFCA meeting on February 6, at which we discussed the future of Lake Accotink. Fairfax County Park Authority has undertaken to revise the Lake Accotink Park Master Plan, and there have been indications that the Park Authority wants to get rid of the dam and, therefore, Lake Accotink as we know it.

The lake is quickly filling with sediment, and the Park Authority must make some tough decisions. Dredging is very expensive and will require a bond for funding, but the dam currently traps nearly half of all sediment washed down from upstream. This makes the dam essential to the health of Accotink Creek below the dam. The lake is essential for many birds, including ospreys and the pair of nesting bald eagles and the juvenile bald eagles that depend on it for food and habitat. It should go without saying that Lake Accotink is also a unique recreational resource for Fairfax County.

Please read the article "Lake Accotink Will Be Gone In 7 Years" on page 8 of this issue of The Ravensworth Farmer to become familiar with the options regarding the lake's future.



# LAKE ACCOTINK WILL BE GONE IN 7 YEARS

The future of Lake Accotink, including whether it will continue to exist at all, is on the front burner. There has been some discussion within the Fairfax County Park Authority of tearing down the dam and eliminating the lake. I believe Lake Accotink is a community asset worth saving, but the issue is complicated and community input now is critical.

Lake Accotink has been dredged three times, at increasing cost. Unfortunately, sediment from upstream continues to settle into the lake, and one of the past hurricanes filled in much of the last dredge. Absent a new dredge, the lake is projected to fill in by 2025.

The lake is being studied as part of the Park Authority's Master Plan review for Lake Accotink Park. The Park Authority has developed six options for the future of the lake. The decision between those options will determine how the rest of the plan is constructed.

### Here are the six options:

- 1. The first option is to do nothing and let the lake naturally fill up with sediment. This would turn the lake into a wetland area and take away its use for watersport recreation by 2025. It would allow the valley to return to its "natural" condition. It would require some dam maintenance which would cost around \$4,700,000 every 30 years.
- 2. \* The second option is to keep the lake as it is by dredging every 15 years. Under this option, the initial full dredging would cost \$29,275,000. A re-dredging would have to take place every 15 years and would cost \$29,275,000 each time in current dollars.
- 3. \* The third option keeps the lake and provides a more permanent fix. The lake would be dredged, and we would also construct a sediment forebay. The forebay is a small, mini-lake at the beginning of the larger lake. The forebay would collect the sediment that currently is filling in the large lake. Each year after the initial dredge only the forebay would be dredged. The large lake would remain as is and would not need re-dredging for about 30 years. As an added benefit, the annual forebay dredges would remove sediment and thus provide an environmental benefit, as sediment carries pollution from storm water runoff. This option would cost \$45 million for the initial dredge and forebay construction, and \$776,000 per year to dredge the forebay.

\*Editor's Note: At the February 6 RFCA meeting, Supervisor Cooke noted that options 2 and 3 cost so much beyond any possibility of being incorporated into the Fairfax County Park Authority (FCPA) budget that either one would require funding from Fairfax County via the Board of Supervisors. Obtaining the money would likely require issuance of a bond. Supervisor Cook said he would need a campaign pushing to Save Lake Accotink, including a petition with at least 1,000 legitimate signatures, in order to get the attention (and votes) of those Supervisors whose districts aren't affected by Lake Accotink. Their approval is necessary to get the bond question on a ballot or otherwise secure funding.

- 4. The fourth option is the installation of "beaver dam" structures in line with Accotink Creek upstream of the lake. These small dams would catch sediment upstream and keep the main lake area as it is. However, the small dams would eventually fill up with sediment and could not be dredged, so eventually we would be back to current conditions. This option is a less expensive, albeit temporary, solution. This would cost \$933,000 for the installation. [Editor's Note: Supervisor Cook said at the February 6 Civic Association meeting he has since been notified by the Parks Authority that this option as a stand-alone has been rejected. It might still be used in conjunction with another option.]
- 5. The fifth option: removing the existing dam and returning Accotink Creek to a single stream within its current limits. This option has an upfront cost of \$11,465,000 for dam removal, with only \$26,000 per year in annual costs. The stream valley would eventually fill in and become a meadow and then forest, with the stream running through it. Sediment would run through the stream and be deposited downstream.

6. The final option is the removal of a portion of the existing dam to create a smaller lake along with a single thread channel. The remaining lake would be 20-25 acres, compared to the current lake of 50 acres (navigable area of the lake is currently 30 acres). The stream would not run through the lake, but around it, so sediment would not fill up the lake, but instead continue downstream. This option would cost \$13,218,000 initially and \$26,000 each year for vegetation maintenance. There are no numbers yet on the cost for any re-dredging.

The Park Authority outlined these options at its January 22, 2018 meeting. Some attendees to the meeting came away with the impression that the Park Authority favored getting rid of the lake. Staff further announced at the meeting that public comment on the proposals would be closed February 26, with a final decision coming later in the year.

Since that time, I have met with the Director of the Park Authority, and am happy to announce that the public comment period, at my request, has been extended into [May]. The Park Authority has also committed to conducting additional community meetings. I also conveyed what I believe to be strong community support for the lake. In light of these discussions, I believe the Director is very open to options to preserve the lake.

The cost of preserving the lake is high, and that is an important factor in any decision. But as a county of over one million people, we regularly make significant investments in parks, libraries, community centers, and other infrastructure for the betterment and enjoyment of the public. This project is no different. I am ready to work with my colleagues on the Board of Supervisors to find funding for an option that preserves the lake, if the community, after knowledgeable discussion, prefers that option.

# VOTE, LEARN, AND EAT - MARCH 22

# FREE TAX PREPARATION AND E-FILING, COURTESY OF AARP

The AARP Foundation Tax-Aide program provides free federal tax return preparation and e-filing from Feb. 1 (Mason District Government Center will open January 29) through April 18 by volunteers certified by the IRS.

Counselors handle almost all forms of income and work with taxpayers to help them get all the deductions and credits for which they qualify. Although the program has no income limits, Tax-Aide clients are generally low- and middle-income taxpayers.

You do not need to be an AARP member to take advantage of this service, which is available to taxpayers of all ages, with special attention to seniors. Taxpayers need to bring: photo ID; Social Security cards for themselves and dependents; a copy of last year's tax returns (even if taxes were done at the site the prior year) and all tax documents they have received such as W-2s, Social Security benefit statements, 1099 interest, dividend, and pension/IRA statements, and brokers' statements.

Self-employed individuals should bring information about the earnings and expenses of their businesses. Also necessary, for those who itemize deductions, are documents and records concerning deductions such as mortgage interest, real estate tax, personal property tax, medical expenses and charitable contributions. Those claiming education credits should bring form T-1098 from the relevant educational institution and records of outlays for tuition and other qualifying expenditures such as course books.

# NEW TIGER AT NATIONAL ZOO

There's a new tiger in town! Meet Pavel, a 10-year-old Amur tiger who lives at the Smithsonian's National Zoo's Great Cats habitat. He made his debut January 5 and is the first of his endangered species to be on exhibit here in 70 years. In this Q&A, get the scoop on Pavel from Great Cats curator Craig Saffoe.

### Why did Pavel come to the Zoo?

To put it simply, we love tigers! Recently, the Great Cats habitat has been home to Sumatran tigers primarily. The last time we exhibited Amur tigers was 1948—70 years ago. We have the space and capability to house three large cat species.

In the past 8 years, we've had great success breeding our adult African lions—Luke, Naba and Shera—and they have produced 13 cubs. Having so many lions meant that we only had space for them and Sumatran tigers. Now that our lions are getting older and most of their cubs have been sent to other zoos per the Association of Zoos and Aquariums' Species Survival Plan recommendations, we have created space for another large carnivore species. My team is excited to have the opportunity to educate visitors about the different subspecies of tigers and the ongoing conservation efforts in their native habitats. Although we do not have plans to breed Pavel, we look forward to breeding this species in the future.

# What is his personality like?

Like most big cats who are introduced to a new place and new people, he is reserved and cautious when it comes to exploring his environment. That said, he is interacting well with his keepers and appears to be a relatively laid-back tiger.

### Are Amur tigers different from Siberian tigers?

Amur tigers are commonly referred to as Siberian tigers, a nickname they received because of the region where they were found. Unfortunately, populations are declining due to habitat loss and poaching, both of the cats and their prey. Today, only about 360 tigers remain in a smaller geographic area near the Amur river, which is why scientists now refer to them as Amur tigers.

# How can visitors tell these the two tiger subspecies apart?

Size and the color of their fur are the biggest clues for telling the two subspecies apart. Sumatran tigers are native to the forest of Sumatra and are the smallest of the subspecies; on average, a fully grown male weighs about 250 pounds. Amur tigers are found most commonly in the forests of Russia and China; they can weigh up to 600 pounds and are the world's largest cat species. Pavel weighs about 310 pounds, but he still appears very large in comparison to our Sumatran tigers, Damai and Sparky, and even our African lions.

The physical differences between these two subspecies are largely due to where the cats live in the wild. Amur tigers live up north, where the weather is cold and the extra weight helps them to keep warm. Sumatran tigers, on the other hand, are found furthest south and don't need to pack on as many pounds in their tropical climate.

Apart from size, Sumatran tigers' fur has a burnt-orange hue, whereas the coat of an Amur tiger is a lighter orange color.

### What is the biggest misconception about Amur tigers?

Because of the lighter color of Amur tigers' fur, some people confuse them with Bengal tigers, which possess a recessive gene that affects the color of their fur, making it appear white. This gene does not appear to occur in Amur tigers.
