#### **Civic Association E-Mail List**

- S. Deyampert discussed using an e-mail service to send messages to members of the civic association. A service would guarantee that the association is abiding SPAM laws. The cost per e-mail for the service is one cent per address plus \$5. K. Craig motioned to subscribe to the e-mail service paying for the cost from the association's operating account under Administrative Expenditures. All approved. The motion carried.
- H. Jansen made the motion to adopt the following rules regarding the use of the email service: 1) Only S. Deyampert (with K. Powers as backup) will have the technical ability to send emails to the membership using the service; and 2) Emails will be sent only when individually approved by a majority of the Board except in case of emergencies. The motion was approved. The Board also approved S. Deyampert purchasing \$50 worth of credits from the service to be able to start disseminating emails.
