Opening Discussion

Interactive Community Web Site

Marty R. began the meeting with a review of his conversations w/Cathy Reidel and Tim Mathis(8/31/10 & 9/1/10 respectively) re the interactive community web site, proposed by the Neighborhood Watch Committee. A line item capital expense of \$7k will be added to the 2011 proposed budget. Copies of the RFP were distributed to attendees. Budget

Richmon T. provided attendees w/2010 Budget (thru 8/31/10) and 2011 Proposed Budget. 2011 Budget to include several new non-recurring capital expenses (Attorney Fee for legal consul service: \$300, New Community Web site: \$7K, Supplies for Neighborhood Watch: \$500, and \$1500 for RFCA Front Sign Upgrades.) Several expenses were removed (Springfield Day, Pool enhancement matching fund) or adjusted (Combine the Neighborhood Picnic and Halloween Party: \$700, remove tip from the Hayride expense). Richmon will discuss Directory Printing costs w/Steve Beste and will provide FY10 Pool Enhancement funds to Steve Price. Proposed budget will be presented for approval at the October 28, 2010 General Meeting.

Additional Items

Entranceway

Discussion to search for someone or landscape company to take care of the entranceways to offload Katherine Craig was agreed. Currently overgrown and one entrance covered w/plywood. Attendees will talk w/friends neighbors to find someone who would be willing to monitor/take care of entranceways. Ellen will talk to the HOT lanes to determine if it is their electrical feeds that are under the plywood.
