Old Business

- Richmon advised that he had gotten four calls from residents who want to have the hayride. Dates selected: January 29, 2011; Snow date: February 5, 2011. A notice will be placed in the December *Farmer*. Liability: Richmon will contact Chera regarding liability (association and personal) and send her a copy of the liability agreement from the vendor.
- Kevin Joyce volunteered for position of Corresponding Secretary. He was nominated and a vote was taken. He was unanimously voted in as the Corresponding Secretary.
- Discussion of the Duties and Responsibilities of the Corresponding Secretary:
