#### New Business

# **Commuter Parking**

Marty mentioned that he had spoken with a resident on Bullock who complained that Ravensworth residents are parking on Bullock to be closer to the Metro bus stop. The resident wanted a sign similar to that posted on Adair that states there is No Parking from 8AM - 10AM. Someone mentioned that the problem also exists on Queensberry and Inverchapel off of Braddock. The membership suggested that the residents of Bullock work directly with the county to arrange for a sign similar to that on Adair. The membership also agreed that the map of the Wakefield commuter lot be re-published in *The Farmer*.

# Plans for the Ravensworth Shopping Center

Ellen reviewed her conversation with the owner regarding the future plans for Ravensworth Shopping Center. Those plans include:

- Demolition of Safeway, the hair salon, 7-11, and deli to increase the square footage for another grocery store (possibly) to open sometime in 2016.
- The historical aspect of the shopping center will be incorporated into its design.
- Both banks have closed and the owner would like to bring in another one, but most banks want footage that fronts Braddock Road. This would require reconfiguring the entire shopping center.
- The old post office site has been rented, but the owner is unable to reveal additional details at this time.
- Any renovations to the center will require special zoning hearings and the owner hopes that our community will support him during this process.
- The community may want to the approach the owner about putting in safer walking/biking paths from the community to the center.

# Neighborhood Improvement

Ellen discussed the availability of purchasing tree seedlings through the county for about \$2.00 per tree. The trees would then be made available to the community, for free. She suggested that the association could purchase redbuds, dogwoods, or pines. She suggested that if there is a tree a member would like to e-mail her.
